FRONT AREA: 1 x Purple Plum (T3) - Shorten side growth by 2m - 3m to clear the building.

- 1 x Lawson Cypress (T4) Fell to ground level.
- 1 x Lime (T5) Trim regrowth by 1m back to previous points.
- 1 x Purple Plum (T9) Shorten side growth by 3m 4m to clear the building.
- 1 x London Plane (T10) Reduce back to previous pruning points.
- 1 x Lime (T14) Reduce back to previous pruning points.
- 1 x Bay (T18) Reduce side growth by 2m 3m to clear the building. Remove false acacia sucker shoots nearby.
- 1 x Sycamore (T21) Reduce back to previous pruning points.
