RE: PROPOSED DEVELOPMENT OF THE O2 MASTERPLAN SITE, FINCHLEY ROAD, LONDON, NW3 - DAYLIGHT, SUNLIGHT, OVERSHADOWING AND SOLAR GLARE

We write in response to the clarification points raised by Delva Patman Redler as part of their independent review of the daylight, sunlight, overshadowing and solar glare ES Chapter (letter dated 11 November 2022).

This letter responds primarily to the points raised in relation to the submitted ES Chapter on Daylight, Sunlight, Overshadowing and Solar Glare. Where relevant, these points have also been incorporated into the recently submitted Supplementary ES Chapter.

1. Confirm that the maximum parameters have been adopted for the outline element of the scheme.

Response: The technical assessments for daylight/sunlight, wind and townscape and visual impacts in the original Environmental Statement were carried out on the assumption that there will be plant, equipment and lift over-runs located on the roofs of the buildings.

A supplementary ES Chapter has been produced based on the assumption that the tops of the buildings themselves (excluding plant and lift over-runs) will be built up to the maximum building heights shown on parameters plan 111 (Referred to in this letter as the 'Supplementary ES Max Parameter Massing').

2. Confirm whether any additional properties outside of the original scope were considered for assessment in line with the scoping opinion issued by CBRE.

Response: Detailed assessments to the properties outside of the original scope were not considered necessary. This because the proposed development will sub-tend a 25° angle line taken from the centre of the lowest window. (See enclosed Sections).

This sectional analysis, but based on the Supplementary ES Max Parameter Massing, has also been incorporated into the submitted Supplementary ES Chapter.

3. Confirm why several dates have been selected to run the sunlight exposure assessment, rather than just a single date such as 21 March as recommended by the BRE guide.

Response: The assessment methodology follows that set out in BSI EN17037, which suggests achieving sunlight exposure of at least 1.5 hours on any date between February 1st and March 21st. Our software therefore calculates the sunlight exposure on everyday between these dates and returns the earliest date on which 1.5 hours is achieved (these are the dates shown in the result tables). Where the room does not meet the suggested guidance the earliest date that achieve the highest sunlight exposure level is returned. This may not be the 21 March if the window is affected by a balcony.

The methodology of the submitted Supplementary ES Chapter has been updated to clarify this.

4. Confirm the significance effects ascribed for the properties experiencing negative effects for daylight and sunlight.

Response: The daylight significance effects are set out within the ES chapter. DPR correctly assume that the summaries given within the chapter are the overall significance effects that have been ascribed. However, for clarify enclosed is a table setting out each surrounding property assessed and the ascribed daylight and sunlight significance.

The text of the submitted Supplementary ES Chapter has been updated to confirm the significance of any effect from the Supplementary ES Max Parameter Massing.

For completeness, the enclosed table shows the effects ascribed to each property for both ES Chapters (the ES Chapter and the Supplementary ES Chapter). As will be seen, the overall effect to each property is the same for both assessments.

5. Provide a copy of the sunlight exposure results for all habitable rooms as these are missing from the appendix of the internal daylight and sunlight report.

Response: Tabular sunlight exposure results for all habitable rooms are enclosed.

Full tabular results based on the Supplementary ES Max Parameter Massing are included within the Supplementary ES Chapter Appendices.

6. Confirm whether the updated plans for the ground floor and podium of Plot N4 would have any bearing on the results reported on.

Response: Whilst the updated plans for the ground floor and podium of Plot N4 may have very small effect on the technical results, they will not have a bearing on the conclusions reached. No further calculation work is therefore considered necessary. This is also the case for the revised internal daylight/sunlight report incorporated within the Supplementary ES Chapter Appendices.

7. Confirm the significance effects ascribed for the properties in the cumulative scenario for daylight and sunlight.

Response: Enclosed is a table setting out each surrounding property assessed and the ascribed daylight and sunlight significance in the cumulative scenario.

The text of the submitted Supplementary ES Chapter has been updated to confirm the significance of any effect from the Supplementary ES Max Parameter Massing in the cumulative scenario.
