5-Day planning application for T00556 An Ash tree with an inclusion that splits with a slight breeze with air in between the two trunks. Direction the one trunk will fall will be onto Waterlow Park railings crossing the cemetery boundary by about 12m and thus will reach public footpath. We are concerned that strong winds could take the trunk down.

On the 13th January 2023 the tree surgeon will remove the top of the leaning trunk by approx 20 m, to reduce the risk from the wind immediately.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
