Reasons for approval-1

> The submitted noise report confirms that all plant, machinery and equipment will operate within the Council's adopted noise criteria thresholds. The plant equipment is predominantly located within the basement and as such not within

the vicinity of any sensitive receptors. The dry air cooler located on the 17th floor has been designed with the appropriate mitigation measures in place. The submitted details include an acoustic report which details noise from this plant equipment. The report was reviewed by the Council's Environmental Health Officer who raised no objection.

Therefore, the submitted details demonstrate that the residential occupiers and surrounding residents will not be adversely affected by noise from the plant equipment.

The application site's history and relevant appeal decisions were considered when coming to this decision.

As such, the proposed details are in general accordance with policies A1 and A4 of the Camden Local Plan 2017.
