Proposed Work:

IN COMMUNAL GARDENS: 2 x Willows (T1 & T2) - Prune back to most recent reduction points.

1 x Cockspur Thorn (T3) - Reduce extra heavy weighted limbs by 2m max to help prevent branch failure.

1 x Maple (T4 & T5) - Reduce back to most recent reduction points.

1 x Oak (T6) - Crown clean removing diseased and crossing branches and lift to 3m.

1 x Cherry (T8) - Crown clean removing diseased and crossing branches and lift to 3m.

1 x Walnut (T9) - Crown clean removing diseased and crossing branches and prune back from property hedge line by max 2m to retain natural shape.

1 x Mulberry (T10) - Lift to 3m max.

1 x Apple (T11) - Prune back heavy weighted limb over property by 1.5m max.

The Council has considered your notification of intended works to trees dated 03 December 2022 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is

completed, which ever is the sooner.

- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
