- T1 Holly x 1 (Ilex aquifolium) This 7m holly tree has been reduced previously. Suggested work:
 - reduce back to previous reduction points
 - reduce the height by 1.5-2m
 - reduce the lateral growth by 1-1.5m to shape

- T2 Yew Common x 1 (Taxus baccata) This 7m yew tree has previously been reduced. Suggested work:
 - reduce the height by 2m
 - reduce the lateral growth by 1m

- T3 Lime x 1 (Tilia spp) This 8m lime tree has previously been pollarded. Suggested work:
 - reduce back to previous reduction points
 - reduce the height by 1.5-2m
 - reduce the lateral growth by 1-1.5m
 - no furnishing growth
- rear garden right hand side
- T4 Lime x 1 (Tilia spp) This 8m lime tree has previously been pollarded. Suggested work:
 - reduce back to previous reduction points
 - reduce the height by 1.5-2m
 - reduce the lateral growth by 1-1.5m
 - no furnishing growth
- rear garden left hand side
- T5 London Plane x 1 (Platanus x hispanica) This 22m London plane tree is centrally located and it apparent good health. Suggested work: - lift to 9m all round
 - clean trunk of epicormic growth
 - carry out aerial massaria inspection, remove any massaria affected limbs, write up findings

 - o sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ\,$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
