Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Tree 1 – T1 - Horse Chestnut - Aesculus hippocastanum

The tree is large for the space and has been unsympathetically pruned in the past such that the form of the canopy is unbalanced.

The prevalence of Horse Chestnut Leaf Miner Moth (Cameraria ohridella) in the area means that the leaves are blotched and discoloured from summer onwards and early leaf loss is common. It is not a suitable tree for a garden this size.

Proposed to Fell to ground and stump grind and replace with at least 2 x small to medium sized trees elsewhere in garden that are good for wildlife (birds, insects) and will increase the diversity of trees in the space. Range to select from likely to include Prunus, Malus, Sorbus, Amelanchier.

Increase in sunlight will also allow a wider range of plants to be grown in the garden, improving the environment for invertebrates and birds in particular.

Tree 2 – T2 - Holly – Ilex aquifolium

The tree has 2 trunks and has not been maintained for some time so the canopy has become rangy and drooping in places.

Proposed to reduce canopy height and spread by 30% and prune to shape canopy to formal cone shape or similar.

Hollies respond well to maintenance pruning, and the work will improve vigour and canopy thickness.

A formal shape will fit well with the surrounding architectural styles, including that of the new house consented on the site.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

e.g. Oak (T3) – Whole crown reduction to 12m above ground level, to provide sufficient clearance to property.

Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
