## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

This application concerns a mature Betula Pendula located in the rear garden at 15 Willow Road. The specimen is located near the boundary of 14 Willow road with several branches overhanging the neighboring property. No pruning has taken place for several years at least. The neighbors at 14 Willow Road have asked that the overhanging branches be removed to decrease shade and prevent as much material (flowering material and leaves) falling onto their patio. The resident at 15 Willow Road has given their approval. We act as gardeners for both properties and as such can carry out pruning to the satisfaction of both parties. We would like to Due to the prevailing wind direction, much of the growth tends towards the east, so this pruning will also help to rebalance the tree's structure. Lower branches to be trimmed back between 1-2m where overhanging neighbours property, and crown to be reduced on eastern side by up to 2m, again where crossing boundary between 15 and 14 Willow Road.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
