Walnut (T1) - Reduce crown to 1m below previous cuts. The tree dominates the garden (half of which is lower than ground level), and is very close to the house behind. The pruning will reduce the size of the tree to keep it in proportion with the size of the garden, and restrict root growth and therefore any chance of damage to surrounding properties.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
