The entire linear garden retaining wall and balustrade to the communal gardens at the front of the terrace.

The retaining wall and balustrade are a post-war reconstruction following bomb damage, a prolonged period of neglect and subsequent and differential movement and structural destabilisation from tree root growth. The entire structure is dangerous, fenced off, and temporarily braced with scaffolding. Expert structural engineering advice has been obtained which recommends that the entire linear structure is is reconstructed on a like - like - basis, but to a higher visual, aesthetic and architectural standard than the existing failed post war reconstruction to more closely resemble the original design and appearance.
