The tree in question is a chestnut tree. We would like to raise the crown by 1-2 meters and do general trimming on all of the tree of about 30%.

The tree hasn't been cut in over 5 years as is now extending into both of the neighbours' gardens.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ\;$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ~$ showing the approximate distance between the application tree(s) and buildings
 - $\circ\;$ adding other relevant features on the site (e.g. greenhouse, paths)
