T1: Griselina (5m): Pollard to 50% of current height as part of regular maintenance and to keep tree at a size suitable for its location T2: Crab apple (4m): Fell as client wants to replace it with a more suitable species T3: Purple plum (6m): Reduce height by 2m and shape as part of regular maintenance and to keep tree at a size suitable for its location T4: Hazel (5m): Fell as client wants to replace it with a more suitable species T5: Apple (5m): Crown reduce by 1m as part of regular maintenance and to keep tree at a size suitable for its location

 - o mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
