Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1) Pine on rear boundary: This tree is in decline with significant die-back throughout the crown. T1 is surrounded by mature trees and removing it will not reduce foliage cover. Neighbouring trees will quickly grow into this space.

Proposed work: Remove to ground level.

T2) Semi-mature Poplar on South West boundary: This tree has a disproportionate and leggy form and offers low amenity value. T2 is in shade of much larger mature Poplar and has grown disproportionately to reach light. T2 is surrounded by mature trees so removing it will not reduce foliage cover in this area. Crown-reducing T2 will not improve the trees amenity value and is not worth retaining. Established semi-mature trees in this area will grow into the space.

Proposed work: Remove to ground level.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
