1 Reasons for approval-

The applicant (British Land) has worked with several prominent artists to develop a series of artworks and installations on-site. This involves working with numerous partner institutions to develop programmes that engage communities. The applicant has also engaged with Regent's Place Pride, Global Generation, Black History Month, and a series of employment and employability programmes. The applicant has consulted on the plan with New Diorama Theatre, Old Diorama, West Euston Partnership, Euston Town BID and other agencies and organisations.

The next stage of the public art at Regents Place is that the applicant will commission high-quality artworks that engage local communities including those that reflect local diasporic communities and artists.

There will be an ongoing programme of events and activities for local people. The applicant has committed to undertake two event-based (ephemeral) arts activities. Each of these events will be new and additional to the existing offer at Regents Place.

There will be a temporary exhibition on site. This will involve working with a professional artist or arts organisation on an ongoing basis. The applicant will work with diverse groups of local residents and pupils.

The applicant will develop one semi-permanent artwork, commissioning a professional artist/and or organisation to work with the local community to create a piece that reflects the history and heritage of Regents Place.

There is a commitment to work with Camden-based artists, including 'Global majority artists' and those from the diasporic communities in the local area, and with students studying art at local schools and colleges including Central Saint Martins University of the Arts and The Slade School of Fine Art.

The applicant is reminded to engage with the Council's Culture Team during the next stage of the programme.

Therefore the plan is considered sufficient to discharge condition 9. The details are in accordance with the requirements of Policy D1 of the London Borough of Camden Local Plan 2017.
