SUMMARY OF ADVICE BULLET POINTS

The principle of a two-storey rear extension is acceptable in design terms. The preferred form of the two-storey rear extension would therefore comprise of a two-storey, half-width solid element and a single-storey half-width glazed element at lower ground floor level. The extent of the fenestration at lower ground is acceptable. The spiral staircase proposed to the rear is uncontentious. The principle of a mansard roof extension is acceptable, given the prevalence of mansard roofs to properties on both sides of Parliament Hill. The two front dormer windows align with the pattern of fenestration below and is acceptable in design terms. A glass balustrade is proposed to the terrace. This would be unacceptable in design terms, and should be amended to black metal railings instead. The works to widen the front entrance stairs to restore the original width and appearance, as well as matching the adjacent properties, would have a positive impact on the appearance of the property. The drawings appear to show the extension to be set back from the side boundaries by approximately 0.8m, which would minimise the impact on neighbouring properties in terms of sense of enclosure and loss of light. There would be no loss of privacy as a result of the rear extension. The proposed rear dormer is unlikely to have any negative impact on residential amenity in terms of loss of light, outlook or privacy. Other properties along this side of Parliament Hill have terraces at roof level, including at the adjoining property no. 30. Given that the view from the terrace would be similar to the view from the windows below, it is not considered that the proposed roof terrace would lead to any loss of privacy to neighboring properties. The principle of a rear extension to this property is acceptable.
