We purchased the Property as an existing HMO, and have recently been informed by the Council that there is no planning or building regulations for such use and as such we should obtain a Lawful Development Certificate. Since the use has been continuous (we have attached ASTs granted over the Property evidencing this) and we have been granted HMO Licences by the Council in the past for this use (originally in 2014 to the prior owner, and subsequently in 2017 following our purchase in 2015 - a current application for renewal is pending at Camden Council), a Lawful Development Certificate should be granted.
