**In the matter of an Application for a Certificate of Lawful Existing Use or Development (for a claimed existing use) in respect of the North Fairground Site, Vale of Health, Hampstead, London NW3 1AU: 2021/5819/P (the "CLEUD Application")**

We write on behalf of the above society in relation to the above application published in your weekly list on 6<sup>th</sup> January 2023.

Our society comprises residents of the Vale of Health and is established for public benefit in the area of the Vale of Health and its purposes include the promotion of high standards of planning and the preservation and protection of the Vale of Health and its environs.

We refer to the letter dated 24<sup>th</sup> January 2023 and the accompanying advice of Counsel submitted jointly by the Heath & Hampstead Society and our society (the "**Joint Letter**"). Our request (and expectation) is that Camden should simply refuse to grant any CLEUD in response to the application - on the basis set out in that Joint Letter.

As a general matter, we trust, request and would expect that (in carrying out your work diligently) you will consult directly with the Vale of Health Society.<sup>1</sup>

We trust that you will carefully consider our representation recognising our standing and interest.


