T2: Mature Sycamore: Approximately 16.00m: Reduce lateral and sub lateral branches overhanging The White House, 2 Millfield Place by up to 3.50m, pruning back to suitable growth points. Thin crown density by 25% throughout the whole crown. Control encroachment. General maintenance.

 - o showing the approximate distance between the application tree(s) and buildings
