Town and Country Planning (Tree Preservation Order) Regulations 1999

GRANT CONSENT FOR WORKS TO TREE/S UNDER A TREE PRESERVATION ORDER

Proposal:

IN COMMUNAL GARDEN: 1 x Horse Chestnut (*Aesculus hippocastanum*) (T1) - Reduce crown height by 2m and laterally by 1.5m - 2m back to suitable growth points. Reduce weight on the branch growing over the road and into streetlight by reducing by 2.5m.

1 x Lime (*Tilia* spp) (T1) - Reduce back to previous reduction points leaving the furnishing growth by approx. 2m around. Lift crown to 2.5m and away from the sycamore.

1 x Yew (*Taxus baccata*) (T1) - Cut back towards boundary by 30cm - 40cm using hedge trimmers.

1 x Loquat (*Eriobotrya japonica*) (T2) - Weight reduce tips by 0.5m - 1m using long arms.

The Council has considered your application dated 13 December 2022 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

- 1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and standards of the work.

- 2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).

- 1 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
