Town and Country Planning (Tree Preservation Order) Regulations 1999

GRANT CONSENT FOR WORKS TO TREE/S UNDER A TREE PRESERVATION ORDER

Proposal:

IN COMMUNAL GARDEN: 1 x Lime (*Tilia* spp) (T1) - Re-pollard.

1 x Holly (*Ilex aquifolium*) (T2) - Reduce in height by 2m and cut back towards plantation on both sides by 20cm - 50cm.

1 x Holly (*Ilex aquifolium*) (T3) - Reduce in height by 3m to match the neighbouring Holly. Cut back on both sides by 20cm - 50cm.

1 x Lime (*Tilia* spp) (T4) - Re-pollard from Lime (T1).

1 x Sycamore (T1) - Reduce 2m - 2.5m all around back to previous reduction points leaving furnishing growth.

1 x Lime (*Tilia* spp) (T1) - Reduce back to previous reduction points by 3m all around leaving furnishing growth. Lift crown to 4m.

The Council has considered your application dated 14 December 2022 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

- 1 This decision is valid for 2 years from the date of this decision or until the work is

completed, whichever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and standards of the work.

- 2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).

- 1 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
