Identification of Tree(s) and Description of Works

My client wishes to apply to remove the mature London Plane tree located in the front garden of the subject property. The tree is referred to as T1 in the accompanying report, Ref: 10347-B Tree Related Damage at 11 Park Village West.

The reason for the proposed works is to reduce the risk of vegetation-related subsidence to the property and prevent further damage to surrounding structures and surfaces.

Whilst it is acknowledged a Section 211 Notice to remove T1 resulted in the creation of a tree preservation order, my client wishes to reduce the risks of any tree-related issues occurring to the subject property or to any neighbouring properties.

Please refer to the accompanying Tree Report, Ref: 10347-B Tree Related Damage at 11 Park Village West, for more details.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
