Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T5, London Plane. Defects noted after climbing inspection which have resulted in further work recommendations. There are Large linier wounds at approx 8-9 mtr's, not occluding well, with the large canopy forming above an abrupt bend in the main stem where the wounds are located, I am concerned about the amount of weight above these wounds and recommend reducing the height to alleviate the weight and lessen the risk of future failure. (Please see annotated T5 photo 001, Proposed new canopy outline, T5 Photo 002, showing wound on stem, & T5 Photo 003, showing abrupt bend were wound is located)

T8, London Plane. Large lateral limb over the road, after carrying out the climbing inspection, a larger cavity was noted 1 would suggest removing this lateral limb, leaving an approximate 3 mtr section, so as not to leave a large wound on the main stem. (Please see annotated T8 Photo 004 & T8 Photo 005)

T9, London Plane, remove major deadwood, exceeding 20mm in diameter, lift lateral secondary branches over the highway up to a height of 6.5 metres.

T11, London Plane, Young tree, historically lost a limb, reduce height and spread by 1-2 mtrs to form a more compact crown.

T13, Lime, remove major deadwood, exceeding 20mm in diameter, lift lateral secondary branches over the highway up to a height of 5.5 metres

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - · sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
