NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA

Proposed Work:

REAR GARDEN: 1 x Bay (T1) - Reduce crown height by approx. 2.5m - 3m. Reduce lateral and sub lateral growth by up to 1.5m.

1 x Sycamore (T2) - Reduce crown by up to approx. 1.5m back to previous, most recent reduction points.

1 x Multi-stemmed Hazel (T3) - Raise crown by approx. 1.25m by means of removing the low front stem. Thin crown density by approx. 30%, selecting healthy young stems for retention. Reduce crown all round by up to approx. 1.5m.

1 x Magnolia Grandiflora (T4) - Reduce crown by up to approx. 1.25m all round, concentrating on lateral and sub lateral growth over the lawn area. Balance and shape.

The Council has considered your notification of intended works to trees dated 14 December 2022 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS

3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
