T1) Apple: Tidy crown by removing vertical re-growth, crossing branches and dead wood; target prune any longer growth to bring into a tidy and uniform shape, reduce by up to 1 metre branch lengths.
T2) Willow: Thin by removing 15% of secondary growth, any crossing branches and dead wood.
T3) Acer: Tidy crown by removing vertical re-growth (up to 2.5 metre branch lengths) and any crossing benches.
T4-T7) Row of 4 Lime trees in 7 Reddington Gardens, NW3 7RU (neighbouring property): Reduce any lateral growth away from 36 Redington Road property to give 1.5 metre clearance.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
