T2 Copper Beech (Fagus sylvatica purpurea) Large tree on up slope side of path up to house. Meripulus giganteus – Giant Polypore at base
of tree
Reduce height and spread by 5-6m
T3 Copper Beech (Fagus sylvatica purpurea) Large tree on down slope side of path up to house. Meripulus giganteus – Giant Polypore at base of tree Reduce height and spread by 3-4m
Troduce height and spread by orthin
