"Detailed drawings, or samples of materials as appropriate, in respect of the following, shall be submitted to and approved in writing by the local planning authority before the relevant part of the work is begun:

- a) Details including plans, elevations and sections at 1:20 of all new windows (including jambs, head and cill), ventilation grills, screening, balustrades, parapets, planters and lighting fixtures;
- b) Manufacturer's specification details of all facing materials (to be submitted to the Local Planning Authority) and samples of those materials (to be provided on site). Samples of materials to be provided at a suitable size (eg. 1x1m) and alongside existing building.

The relevant part of the works shall be carried out in accordance with the details thus approved and all approved samples shall be retained on site during the course of the works."

The documents submitted alongside this covering letter will discharge the required details for Condition 4 (a) and (b). Further, the samples demonstrated within the facing materials document (18STU-TFO-AR - Sheet - 4401 - Facing Materials) will be provided on-site to enable Westminster to sufficiently assess their impact. Please contact the planning agent to arrange suitable dates for a site visit.

In view of the above and the enclosed, we trust that all the requirements stipulated in Condition 4 (a and b) can now be discharged. I look forward to receiving confirmation that the information is acceptable to discharge the condition when the decision notice is issued.
