## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T711 - Taxus baccata (Yew):

RAF - Reshape and rebalance crown - reducing the height by up to 60 cm to level top of crown and reducing the low extraneous limbs to north (at around 1 m in height) by 75 cm, to re formalise the visual aesthetic, also improving access to light for the property behind.

T712 - Taxus baccata (Yew):

RAF - Reshape and rebalance crown - reducing the overhang of the footpath by 2 m to improve pedestrian clearance, reduce obstruction to TFL cycles and improve visual aesthetic. Also reduce height by up to 50 cm to level top of crown and re formalise the visual aesthetic.

T713 - Taxus baccata (Yew):

RAF - Reshape and rebalance crown - reducing the overhang of the footpath by 1.2 m to improve pedestrian clearance and visual aesthetic. Also reduce height by up to 50 cm to level top of crown and re formalise the visual aesthetic.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - o mark and name surrounding roads
  - o sketch in buildings, including adjoining properties
  - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - o showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
