Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T491 - Ligustrum lucidum (Glossy Privet/Chinese Privet):

RLS - Reduce specified limb(s) - removing the lowest limb to east attached at 2.8 m back to the main stem and reducing the two limbs to eastnortheast and eastsoutheast attached at approximately 3.5 m by 2 m, to reduce overhang of driveway and remove overhang of car parking, and increase light to shrub bed. Final cuts on the two reduced limbs to be made at suitable pruning points.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

 - showing the approximate distance between the application tree(s) and buildings
 - $\circ\;$ adding other relevant features on the site (e.g. greenhouse, paths)
