T1 & T2) 2 x Holly trees adjacent to Priory Road: Reduce height and width by up to 0.5 metres to bring into uniform shape; provide more defined gap between the trees (upper canopy only).
T3 & T4) 2 x Holly trees on corner of Priory Road & Abbey Road: Reduce height and width by up to 0.5 metres to bring into uniform shape; reduce over pavement by up to 1 metre to provide clearance for pedestrians.
T5) Holly over greenhouse: lightly trim up to 0.5 metres and thin by 15% to provide more natural form.
T6) Olive in rear garden: target prune longest growth by up to 1 metre to reduce height and width at rear of the tree.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - o showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
