I am writing to object to the O2 Centre Application 2022/0528/P for the following reasons.

1 The buildings proposed are excessively tall for the area.

Ten storeys is considered the maximum height for a building in the area. According to London Plan policy D9, paragraph B, "Tall buildings should only be developed in locations that are identified as suitable in Development Plans." In terms of transport alone, it is not clear how this locale can be considered suitable. TFL stations here are already overstretched and have less than adequate access and capacity.

2 The scale of the proposed development is totally out of keeping with nearby Conservation Areas.

The location is barely a few metres outside several Conservation Areas, yet the proposed development has no regard at all for this. Excessively tall or massive buildings are bound to have a negative impact on the local amenity and would wipe out local views (views being a particular point mentioned in A11 of the Neighbourhood Plan).

3 The proposed development does not meet the affordable housing target of 50% specified in Local Plan policy H4.

4 The loss of car-parking would harm people and businesses.

I understand Camden has a policy of car-free development, but applying it in this way and in this place would be counter-productive. There is little other car-parking in the area, so losing parking in this location would mean losing amenities. It would have an especially harmful impact on Sainsbury's and the people who need to use supermarkets. At a time of rising inflation, this becomes even more important because people need food at keener prices. Sainsbury's in the largest and most affordable supermarket in the area and we

already know that, without parking provision at this site, they do not intend to provide a large store.

5 There is insufficient health provision.

As a general practitioner and local resident, I am acutely aware that health services are is under immense strain. Health provision like GP surgeries should clearly keep pace with the growth of the population, and should be provided at an early stage, before the arrival of a large number of new residents who need it. I am alarmed to find that this application only gives the vaguest statement about health facilities. Health appears here to be no more than an afterthought, and that may lead to disaster.

For all these reasons, I strongly urge you to refuse this application.

As an architect, I am appalled by the proposed development on the O2 site. Architecturally it is an abomination both aesthetically in its environment, and more importantly in human terms. The overcrowding, the strain on services which are already at full stretch in this area, the complete lack of any provision for children in terms of play space are, in the long term, a recipe for creating social problems. I can find no access to detailed plans as to what kind of dimensions and spatial organisation is proposed but the provision of only one staircase for access and escape, after Grenfell is criminal. Elsewhere in Camden what is clear is provision for up market owners and renters at the expense of decent and adequate quality of living for ordinary people.

What I find beyond belief is that there is no sign at all that the changes needed to begin to tackle climate change have played any part at all in this scheme. I understand all the limitations and problems caused by the government cuts, but there has been so much work done in parts of Europe on changing how we build, heat and provide green spaces and nothing seems to have even been given a nod to. It is just another case of developers being given a green light to create maximum profit for themselves and the council to get a temporary bit of extra funding. Clearly no wake up call has been heard in you department about what are the most urgent problems we face.

I would like to add that these views are also shared by my wife. We hope human decency will prevail when you come to make your decisions of what kind of environment you wish to create / promote in Camden.
