I would like to protest against Planning Application 2022/0528/P.

The projected building of 12 tower blocks, each 12-15 storeys high will change for worse the life of all inhabitants in the area.

The impact of projected new 1800 flats will be catastrophic for the traffic on the 2 main roads in the area - West End Lane and Finchley Road. There will be no enough shopping facilities for the people as O2 Centre, Sainsbury's and Homebase will be lost. We'll have to go shopping in the neighbouring areas using our cars and bikes which will be additional burden to the main two roads, it will increase the traffic to impossible to travel level.

The two main underground stations West Hampstead and Finchley Road will be overcrowded. They are overcrowded now, what could we expect in the future?

I also would like to object strongly to the proposed overdevelopment of the site so close to South Hampstead Conservation Area.

The "Townscape, Heritage and Visual Impact assessment, Version 1" prepared by Tavernor Consultancy does not represent correctly the enormity of the visual impact of such a massive development. All pictures are taken with a wide lens distorting the view. This is very visible on page 116 where Finchley Road looks like a motorway and the Waitrose building looks like a bungalow.

Much more importantly there is no assessment of the visual impact on the people living in Broadhurst Gardens, Compayne Gardens and Canfield Gardens. All the images representing the visual impact in the report are taken with east-west orientation. All the windows of the people living in these streets are south-north. The north side of their view will be blocked by the very close 15 stories tower blocks. The report completely ignores Compayne Gardens and Canfield Gardens.

There is also no representation of the Finchley Road view directly opposite the present O2 Centre. The reason is very obvious – it would be difficult to distort the view to make the blocks look smaller and "neutral" as they try to call them.

The blocks should not be higher than 6-7 stories to fit into the present environment and not be the sore eye of the area.

I note that in the planning application it is mentioned very vaguely that at a certain stage in the future there will be built new health and GP surgeries, etc. When, in 15 or 20 years? What the new 5000 or 6000 tenants/inhabitants would do until then? It means that there will be practically no normal health services in the area for many years. Please do not allow the building of the projected 1800 flats. The construction of so many buildings and flats will destroy or harm the existing infrastructure and local environment for an unpredictable long term.
