## Specifically:

- -The existing amenities of the 02 Centre (including the full size Ssainsburys not some unspecified size replacement like the developer promises its restaurants, bookstore, coffee shop and children's play area) were one of the main reasons I purchased a home in the area not long ago and enjoy on a very regular basis.
