Town and Country Planning Act 1990

Certificate of Lawfulness (Proposed) Granted

Reason for the Decision:

1 The sash windows in the front and rear roof gables are permitted under Class C of Part 1, Schedule 2 of the Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended).

Informative(s):

The development subject to the grant of this certificate would only constitute permitted development where the window cil would project no more than 150mm beyond the plane of the roof, in accordance with Condition C.1(b) of the Town & Country Planning (General Permitted Development) Order 2015.

Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays. You must secure the approval of the Council's Noise and Licensing Enforcement Team prior to undertaking such activities outside these hours.
