We would like to do a standard reduction to Sycamore trees 1 and 2 by about 3 metres in height in order to allow more light in to the property and gardens. This will also help minimise root expansion as the trees are close to the building.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
