Proposed Work:

FRONT GARDEN: 1 x Sycamore (Acer pseudoplatanus) (T1) - Reduce by 30%, 3m to previous points of reduction.

SIDE GARDEN: 1 x Laburnum (L. anagyroides) (G1) - Reduce height by 1.5m, thin by 15% and shape to tidy.

- 3 x Sycamores (Acer pseudoplatanus) (G2) Reduce height by 30%, 1.3m and shape to balance and tidy.
- 1 x Ash (Fraxinus excelsior) (T2) Reduce to previous reduction points, (1.5m regrowth) and shape to tidy.
- 3 x Sycamores (Acer pseudoplatanus) (G3) Reduce height by 30%, 1.5m to previous reduction points and shape to balance and tidy.

REAR GARDEN: 3 x Fig (Ficus carica) (G4) - Reduce height by 1.5m, thin out all new growth by 10% and shape to tidy.

- 1 x Evergreen 'Holm' Oak (Quercus ilex) (T3) Section fell to ground level.
- 1 x Bay (Laurus nobilis) (T4) Reduce height by 40%, 1.3m to suitable growth points to regrowth to rounded canopy line. Trim back all sides by 0.75m to shape and tidy.
- 1 x Cotoneaster (C. fridgidus) (T5) Fell to ground level.

The Council has considered your notification of intended works to trees dated 16 January 2023 and does not wish to object.
