




Existing Internal Elevations Second Floor






Existing Internal Elevations Third Floor




5. Lecture Hall Existing Floor Plan


1. Lecture Hall Elevation 1




Existing Room Layout Lecture Hall Sheet 01






9. South Jury Rooms Elevation 5




10.South Jury Rooms Elevation 6








13.Library Existing Floor Plan






14.Library Existing Reflected Ceiling Plan




1. Library Journal Room Elevation 1






5. Library Gallery Elevation 1






Existing Room Layout Library Sheet 02









2. Front Member's Room Elevation 2




Existing Room Layout Front Member's Room

5. AA Bar Existing Floor Plan








6. AA Bar Existing Reflected Ceiling Plan
