T1) Lime tree adjacent to Sauna: This tree has significant decay in base: Remove all branchwood (pollard); reduce stem by a further 2 metres to provide more structurally stable form.

T2) Sycamore: This tree has major decay throughout the upper canopy: Overall crown reduction by up to 4 metres to provide a safe and structurally robust framework.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
