Proposed Work:

REAR GARDEN: 1 x Plum tree (T1) - Crown lift up to a max. of 5.4m over the road and 2.4m over the pavement.

2 x Lime (T5 & T6) - Crown lift up to a max. of 5.4m over the road and 2.4m over the pavement.

1 x Oak (T9) - Crown lift by up to 4m over a green space area with seating.

1 x Sycamore (T8) - Crown lift by up to 4m over a green space area with seating.

FRONT GARDEN: 1 x London Plane (T2) - Crown lift up to a max. of 5.4m over the road and 2.4m over the pavement.

1 x Cherry (T3) - Crown lift by up to 2.4m over the car park.

1 x Apple (T4) - Crown lift by up to 2.4m over the car park.

SIDE GARDEN: Group of mixed species (G1) - Prune back lateral branches by up to 2m away from the building.

The Council has considered your notification of intended works to trees dated 15 January 2023 and does not wish to object.
