1 x Azara (T33) - Reduce back to most recent reduction points, 3m - 4m. Remove epicormics and basal shoots.

1 x False Acacia (T34) - Reduce back to most recent reduction points, 3m - 4m. Remove epicormics and basal shoots.

1 x Maidenhair (T35) - Reduce back to most recent reduction points, 3m - 4m.

1 x False Acacia (T36) - Reduce back to most recent reduction points, 3m - 4m. Remove epicormics and basal shoots.

1 x False Acacia (T38) - Reduce back to most recent reduction points, 3m - 4m. Remove epicormics and basal shoots.

1 x False Acacia (T39) - Reduce back to most recent reduction points, 3m - 4m. Remove epicormics and basal shoots.
