1 x Cherry (T69) - Crown reduce 2m - 3m.

1 x Swedish Whitebeam (T70) - Reduce back to most recent reduction points, 2m - 3m.

1 x Hornbeam (T71) - Reduce back to most recent reduction points, 3m - 4m. Remove epicormics and basal shoots.

1 x Hornbeam (T72) - Reduce back to most recent reduction points, 3m - 4m. Remove epicormics and basal shoots.

1 x Hornbeam (T73) - Reduce back to most recent reduction points, 3m - 4m. Remove epicormics and basal shoots.

1 x Hawthorn (T82) - Reduce back to most recent reduction points, 2m - 3m.

1 x Hawthorn (T85) - Reduce back to most recent reduction points, 2m - 3m.
