Work required- To reduce height by 3-3.5m and all lateral growth by 2-3m to good branch/fork junction and remove any deadwood over 40mm in diameter and or 1m in length

Reason - as part of continued maintenance, to reduce encroachment/debris over play area while keeping reasonable form.

Tree type - Monterey cypress (Cupressus macrocarpa)

Approx Height - 13m

Approx Spread - 6m

Service - Crown Reduction

Work required- Reduce height by approximately 3m and lateral growth over neighbouring property and car park by approximately 0.5-1m without losing green foliage cover to shape and balance

Reason - as per clients instructions, to maintain best compact form, ease maintenance and reduce encroachment
